

Workers of Pars Wagon Company tore down the dinner salon

After 3 months of working without getting paid and several protests in the past today the workers of Pars Wagon Company tore down all the windows, tables, chairs, drawings and rest of the things in this factory's dining salon. The protesting started with a simple action of beating spoons on tables before lunch consumption and due to management carelessness and factory's security threats against the worker things got violent.

It is noteworthy that two other important country's factories i.e. Arak automobile factory and Azar Water Company will pretty soon declare bankruptcy. By state security officials managers of these two company's are trying to postpone these two factories bankruptcy declarations to prevent possible workers protesting of these two factories with other bankrupt factories.

All major industrial factories are busy with contract forces purgation and even professional workers with over 15 years of working experience are among the ones getting fired. Managers of industrial monsters bankrupt are pressing their official workers to accept early retirement and get out of the factories.

Haft Tapeh workers sit ins

Workers of this company on Friday the 16th sat down in factories plant. This sitting in started with workers whistling sound. When representatives of the phony council wanted to interfere through saying, which workers voted and selected you that you want to get into our business workers did not let them interfere. They also chanted against the logging cards' supervisor.

Workers demands in this protest were as the following.

- 1 – Executing the Job Classification project and increasing wage and incomes.
- 2 – Solving the over time working matter (There are problems in regard to the way and amount over time pay is calculated for the workers.)
- 3 – Logging job works during coming and leaving.

And these problems are not routine matters of this production plant.

Now that this project is being executed problems have arisen for workers. Among them include the Friday (Islamic Sabbath) days in months when there is no harvesting, before workers were present until 10 o'clock in factory and then got back home but, with this new project even on Fridays they must still remain until the end of the working hours at their working place and hence they are losing their one and the only opportunity per week to spend with their families.

- 4 – Stoppage of firing the temp workers. By syndicate trying these workers were meant to become officials but now under the threat of higher officials they might be fired.

Saravanj Workers protest against pollution caused by production plants in city Downtown

Saravan residents who were sickened by the pollution caused by Cabinet Making, Painting, Welding and Cutting plants in front of their houses in the busiest parts of the city gathered in front of the Living Environment bureau of this city demanding transferring these plants out of the city and into industrial towns.

It is noteworthy that through numerous passing away bureau officials wanted to get matter's responsibility off their own shoulder.

The sound and environmental pollutions in Sistan & Baloochestan province (next to the Pakistan border – trans.) are example of most fundamental repugnance of basic citizens rights that since many, many years ago by the officials.

Coup has reached ministry of education and development in Kermanshah (Summary)

Reliable reports indicate political fight and purging in three districts of the organization of education and development in Kermanshah County. After president election some of the assistants, experts, counselors and principals of schools in all three districts of the organization of education and development were taken off their positions. In 2nd district Rashidinasab fired over 18 principals both women and men. In 3rd district a list of 40 principals and experts have been created who will be fired from their position or have to accept early retirement by force.... Such actions within last four years have caused irreversible damages to educating children... These actions got heated up since over 80% of province faculties did not support Ahmadinejad during the presidency election.

Ongoing protesting from arrested people's families

Gathering in front of the Revolutionary Court; It is two months since we haven't had any news from our children.

Over 120 family relatives of the arrested gathered in front of the Revolutionary Court on Wednesday. People were extremely angry about their beloved ones' unclear condition and wanted their immediate freedom. Every day that passes by families raise the degree of their shouting protests toward Khameneii and Ahmadinejad.

Some of the families contacted Hadad's office to follow up their beloved one's situation but nobody responded to them and Judge Hadad's assistants were yelling at them saying; "Why you come over here so often? Go to your houses whenever there was news we contact you ourselves." Families protested in response saying who gives you the right to be yelling unto us? We are mothers, fathers and it has been two months we haven't heard from our children knowing they are alive or death; nobody is replying to us.

A letter after death of Taraneh, dying on the way for freedom

Recently Fars News Service of the coup makers printed a letter allegedly written by Taraneh Mousavi. Taraneh was a fallen girl whose body was burnt after lots of beating and brutal ongoing raping by the investigators and found in deserts between Karaj and Ghazvin. In this letter it is written like; I am Taraneh Mousavi. I am alive and healthy and nothing has happened to me. My death story is a rumor from regime's enemies.

Taraneh Mousavi was arrested on June 28 2009 around Ghoba Mosque in Shariati Street of Tehran by regime agents. After near three weeks strangers called and informed her mother about her being a patient in Imam Khomeini Hospital of Karaj. These strangers talked about an accident around Shariati street and her womb and anus rapture is the cause of her being taken in the hospital.

One direct witness who also got arrested on June 28 testifies: "The anti uprising forces and plain clothing ones took me and some other arrested ones on vans to a building near Noboniad Square and started hurting us physically and mentally. Some of the ones

arrested were taken to Evin Prison same afternoon but I and the rest were let gone free. Taraneh was among us. She was a pretty, nice shape body wearing good clothing and her interrogation was longer than all of us. Her eyes were green. I and a few were set free that same night and some of the others were transferred to other places before our being set free. But the plain clothing agents kept Taraneh at the same place and did not even let her contact her mother.” Taraneh Mousavi’s father has heart problem and after loss of his only child he is a patient in a hospital.

Threat and more security pressure upon Kianoosh Assa’s family

During past days Kianoosh Assa’s family are under pressure from security officers to prevent from bewilderment according to their saying. Kianoosh Assa, born in Kermanshah, student in the last semester to become senior expert in Chemical Engineering in Iran’s University of Science and Industry was lost during the demonstration in Azadi Square of Tehran on June 15th 09 and, on June 24th he was identified by his family in the coroner cold room. He had lost his life through bullet shot by plain cloth agents and in June 29th he was put into soil for rest in Section 58, #12 of Kermanshah Baghe Ferdos.

Last Thursday August 6th 2009 during the ceremony of fortieth day after his death the security forces began beat and hurt the ceremony participants, using pepper spray and arrested at least ten people. Kamran Assa, Kianoosh Assa’s brother pointed out the severe pressure posed upon them by the security forces and reports his family’s presence in the office of security police within last three days. Mr. Assa was summoned to Revolutionary Court of Kermanshah to give a sort of pledge during which he has been threatened. Today, Wednesday there are news about the possibility arrest on Monday evening although this report up till this report production is invalid.

Based on valid resources the ones arrested on the fortieth ceremony were taken to be pressured confessing things against his family. This report adds that during this interrogation the interrogator allegedly named this family as cause of bewilderment who wanted to urge others to chant anti regime slogans.

Security Force attacking and arresting 15 Balooch teachers

During the last two days security forces have raided into houses and arrested 15 Baloochi teachers in Zahedan city and transferred them to unknown places. According to the report of Human Rights activists in Iran with raiding into people’s houses and contempt toward women and children 15 school teachers in Zahedan cities were taken away to unknown destiny.

Up until now there is not a single report about their conditions and the place they are staying at and no official bureau answers their families. Also it is not clear under what charges they have been busted. Considering rising pressures imposed upon Balooch national minorities it is possible that the school and high school teachers shall be tried for unfounded and nonsense allegations. Further completing news will be provided.

Treatment necessary for a Kurdish prisoner in Urumieh Prison

Keyvan (Mustafa) Davoodi, the Kurdish prisoner in Urumieh prison needs outside treatment due to having platinum in one of his legs.

Keyvan (Mustafa) Davoodi was arrested around a year ago in Darlek three ways, in villages around Mahabad and got 10 years sentencing from the revolutionary court for allegedly working with one of the opposition parties.

This prisoner has asked numerous time to be allowed to receive treatment in one of the medical centers outside of the prison but up until now his request has not been approved.
